Subject: Overview of EASTELPRENEUR - Onboarding Bonus

1. Overview

This campaign provides additional bonus to EASTELPRENEUR who actively expand their network.

2. Terms & Conditions

- a) The Onboarding Bonus is only **eligible** if both the **activation** and **reload** are completed **within** the **same calendar month**.
- b) The bonus amount displayed in the EASTEL App or Portal reflects real-time calculations as estimated; however, the **final eligible bonus** will only be **confirmed** at **month-end**.
- c) This campaign counts will be **reset** by monthly basis.
- d) Where an **MNP** request is **submitted in one calendar month** but the port-in is only **successfully** completed in the **following calendar month**, the EASTELPRENEUR must **fulfil** the reload requirement in the calendar month in which **the successful port-in** occurs **in order to qualify**.
- e) This onboarding campaign bonus is **NOT** convertible to **eCOMM** and is **NOT** eligible for EASTELPRENEUR ranking upgrades.
- f) *Tier E is 12 months promotional campaign starting with the date of issuance of this memo.
- g) EASTELPRENEUR must fulfil the **Minimum Monthly Personal Reload (MMPR)** requirement, whether through **cumulative** reloads or a **single denomination**, according to their rank in order to qualify for bonuses and incentives payout.
 - a. Elite Member: **RM 35**
 - b. Ambassador: **RM 60**
 - c. Senior Ambassador: **RM 80**
- h) The EASTELPRENEUR must be **ACTIVE** status in order to receive bonuses and incentives.
- i) Malaysian must register using ID document regulated by **MCMC** (ie.: **MyDigital ID/MyKad/MyPR/MyKAS/MyTentera**).
- j) Non-Malaysian must provide a **valid passport**.
- k) If an EASTELPRENEUR fails to meet the **Minimum Monthly Personal Reload (MMPR)**, the bonuses and incentives for that month **will be forfeited**.
- l) The service is open to individuals aged **12 and above**, however; bonuses and incentives **payouts** are only eligible for individuals aged **18 and above**.
- m) Bonuses and incentives are disbursed on the **18th of the following month**.
- n) EASTELPRENEUR is required to **activate** the EASTEL Wallet in order to receive bonuses and incentives. If the EASTEL Wallet is **not** successfully activated, the bonuses and incentives shall be **carried forward** until the EASTEL Wallet is successfully **activated**.
- o) All bonuses and incentives **will be credited** to the EASTEL Wallet. A processing fee of **RM 2** shall be **deducted** from each disbursement.

Example: *If the payable bonus + incentive amount is RM 200, the EASTELPRENEUR shall receive RM 198 in the EASTEL Wallet.*
- p) If the total disbursement **exceeds RM 20,000**, only the amount in **excess** of **RM 20,000** shall be credited to the designated bank account.

- q) Minimum bonuses and Incentives payouts threshold are **RM 30** and above.
- r) The said bonuses and incentives will continue accumulating until they meet the **RM 30 minimum threshold**. Once the threshold is met, the bonuses and incentives for all accumulated months will be **paid out in a single lump sum**, Scenarios:
 - a. Month 1 (**MMPR**) met, bonuses + incentive less than RM 30 → carried forward
 - b. Month 2 (**MMPR**) met, bonuses + incentive less than RM 30 → carried forward
 - c. If the Month 3 requirement is met and the total bonuses and incentives is more than RM 30 within a single month, payout for Months 1 to 3 will be made in a **single combined payment**, provided the reload (**MMPR**) is fulfilled (**3 months × Monthly Minimum Personal Reload**).
- s) EASTELPRENEURS must ensure their registration is valid and free from fraud, cheating, or violations of regulations set by **MCMC or any local authority**.
- t) Fraud, misuse, or irregular activities may lead to **suspension or forfeiture** of bonuses and incentives.
- u) Appeals will **not be entertained** if the eligibility criteria for these bonuses and incentive are not met.
- v) These bonuses and incentive are **excluded** from BRN and project-related activities.
- w) In the event of any discrepancy between the **translated version** and the **English version**, the English version shall prevail.
- x) EASTEL reserves the right to amend, update, suspend, discontinue, or terminate any part of this incentive or campaign without prior notice. Continued participation constitutes acceptance of any updated terms.
